

## Ontario Municipal Board Commission des affaires municipales de l'Ontario

The Ministry of Transportation has applied to the Ontario Municipal Board under subsection 37(2) of the *Public Transportation* and *Highway Improvement Act*, R.S.O. 1990, c. P.50, as amended, for approval of the closing of certain roads intersecting the right of way for the new alignment of Highway 69 in the Township of the Archipelago, Geographic Townships of Shawanaga, Harrison and Wallbridge, District of Parry Sound. Ministry of Transportation File No. GWP 5403-05-00 and GWP 5076-06-00, OMB File No. MM120032.

The above project is generally referred to as "Highway 69 Four-Laning and re-alignment from Shawanaga River northerly 25.6 km to 4.8 km north of Harris River, Geographic Townships of Shawanaga, Harrison and Wallbridge" and more particularly shown on Township of Shawanaga "T" Plan No. P-2944-37, Township of Harrison "T"-Plan No. P-2151-58 and Township of Wallbridge "T"-Plan No. P-2534-23. The project limits are shown on the key plan.

## **EXPLANATORY NOTE**

The Ministry of Transportation is expanding Highway 69 to a four-lane divided, controlled-access highway. The four-lane highway will improve traffic operations and overall Regional accessibility, and enhance safety. As part of the four-laning, access to Highway 69 will be restricted to interchanges. No at-grade intersections will be permitted. Accordingly a number of opened and unopened road allowances will be closed at the point where they intersect the new four-lane highway.

This section of Highway 69 will include two interchanges, one south of Pointe Au Baril Station and the other at Harris Lake Road. Sections of existing Highway 69 will be incorporated into a parallel service road network extending from the south project limit to north of Naiscoot Lake and providing access to local roads and properties.
